

REASONS WHY TAMPA BAY COMPANIES SHOULD CONSIDER EXPORTING TO COSTA RICA:

- The United States is Costa Rica's largest trade and investment partner, with 40% of Costa Rican imports of U.S. origin.
- Costa Rica is the oldest, continuous democracy in Latin America, with a sustained pro-business climate.
- Costa Rica is one of the top 10 destinations for Florida exports, receiving \$2.5 billon in merchandise exports from Florida in 2018.
- The Central American Free Trade Agreement (CAFTA-DR) with the U.S. eliminates a majority of tariffs for non-agricultural imports into Costa Rica.
- Port Tampa Bay offers regular direct container services to Costa Rica from Tampa via Seacat Line.

MISSION COSTS AND REGISTRATION

TRADE/GOLD KEY PACKAGE

Grants may cover up to 100% of the Gold Key registration for qualified companies.

Primary Company Representative \$1,200 Additional Representatives \$450 each

Pricing is for small size companies only (per USCS guidelines). Medium and large size companies please contact Global Tampa Bay team for pricing and details.

PACKAGE INCLUDES:

- · Customized counseling on market entry/expansion strategy
- Pre-screened one-on-one matchmaking appointments
- Spanish/English Interpreter
- Country briefing by U.S. Embassy officials
- · Admission to all mission events
- Airport transfers in country when traveling on official mission flights
- Ground transportation to all official mission events
- Each company may be assigned a vehicle and interpreter based on requirements.

Gold Key Service*: The U.S. Commercial Service will schedule one-on-one appointments with pre-screened Costa Rican companies that have expressed an interest in your product or service.

*Gold Key participation will be limited to Florida manufacturers and service companies that best meet the participation criteria. Selection of these firms will be on a first-come, first-served basis. Final selection will be determined by the U.S. Commercial Officer after a review to ensure market suitability.

Enterprise Florida Gold Key Grants: Small Florida manufacturers and professional services providers may qualify for a Gold Key Grant from Enterprise Florida, which will reimburse up to 100% of the Gold Key Package registration fee for the Primary Company Representative.

As part of Global Tampa Bay's Gold Key Package, participants will have the opportunity to take advantage of the unparalleled trade facilitation services provided by the U.S. Commercial Service (USCS) in San José. The USCS will coordinate all oneon-one Gold Key appointments. The USCS offers a variety of products and services designed to facilitate U.S. exports.
